  N.C.G.S. §105-378(a) Use of Remedies Barred states that no county or municipality may maintain an action or procedure to enforce any remedy provided by law for the collection of taxes or the enforcement of any tax liens (whether the taxes or tax liens are evidenced by the original tax receipts, tax sales certificates, or otherwise) unless the action or procedure is instituted within 10 years from the date the taxes became due. Unpaid ad Valorem taxes for 2012 have exceeded the

statute of limitations for the Tax Collector to collect the taxes. Tax Collector Tina Merritt-Smith is asking the Board to consider releasing uncollected taxes for 2012 in the amount of \$2,115.22 (Item #1D.1)
