

# MINUTES OF THE WHITE LAKE TOWN BOARD OF COMMISSIONERS REGULAR MEETING

April 8, 2025

The White Lake Town Board of Commissioners met in regular session at 7:00 p.m. on Tuesday, April 8, 2025, at 1879 White Lake Dr., White Lake, North Carolina. Those present were Mayor H. Goldston Womble, Jr., Mayor Pro-Temp Timothy Blount, Commissioner Paul Evans, Commissioner Terri Hawley, Commissioner Mike Suggs, Commissioner Jake Womble, Town Attorney Whitley Ward, and Town Administrator Sean Martin. Commissioner Dean Hilton was absent. Finance Director, Mary Jo Lennon was also present. Tina Merritt-Smith served as Clerk to the Board.

#### **CALL TO ORDER**

Mayor H. Goldston Womble, Jr., declared a quorum and called the meeting to order at 7:00 p.m.

#### AGENDA ADOPTION

#### MARCH 2025 UTILITY RELEASES (\$4,981.97)

#### WHITE LAKE "LAKE" WATER MANAGEMENT PROJECT UPDATE

Dr. Diane Lauritsen, Ph.D., LIMNOSCIENCES provided her monthly report to the Board. Sean Martin, Town Administrator, presented the Update. Dr. Lauritsen illustrated in her report that the rainfall in the first quarter of 2025 was below average and the lake level has remained static since late December, at 64.5 feet NAVD 88. Dr. Lauritsen also stated that she used White Lake as a poster presentation at a conference in Charlotte, NC, receiving good feedback and suggestions for collaborations. Mr. Layton also expressed his concerns about lake water levels and the need for a math formula to manage the volume of water coming into and out of the lake.


#### Report to Board, Town of White Lake April 2025

## Diane Lauritsen, Ph.D. LIMNOSCIENCES

I attended two conferences in March, one in Raleigh, and one in Charlotte. At the first one I had organized a group of speakers for a special session on onsite wastewater treatment systems (aka septic systems), and I happened to meet the person who had been the acting director of DEQ back in 2018. She was in that position for only a short time, but she had retained her negative view of the town, and Mayor Womble. I mentioned that things had changed considerably and suggested that she look at the White Lake Watch web site. At the conference in Charlotte, I organized a special session on nutrient management which was well-attended, with scientists from North Carolina and around the world. I gave a poster presentation about White Lake, and got some good feedback and suggestions for collaborations, which is why we scientists go to conferences.

I obtained the report on the aquatic vegetation survey done last fall and will summarize the information for next month. The bottom line is that no hydrilla was found.

Rainfall in the first quarter of 2025 was below average and was roughly equal each month. The lake level has remained static since late December, at 64.5 feet NAVD 88.

- The 1<sup>st</sup> place winners of each category from Bladen County will be judged along with the submissions from the other seven counties (Brunswick, Columbus, Duplin, New Hanover, Bladen, Onslow, and Sampson) to determine the regional place winners, 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup>. This phase will be completed by August 30, 2025
- The winning selection(s) for the regional art show will be made by the NC FIFF panel
  of judges and is final. First, second, and third place winners will be determined from
  the submissions in each of the two categories (high school and adult). The regional
  judges will use the same criteria to determine the overall regional winners: submitted
  artwork encapsulates the concepts of freedom and patriotism, celebrates America at
  250, and is inspirational.
- The winning art submissions from each county will be on display at the Pender Arts Council, 111 S. Wright St, Burgaw, NC and then at Moores Creek National Battlefield from February 21-28, 2026 and possibly other venues TBD. The artwork will be released by the NC FIFF Art Contest Committee back to the appropriate counties as quickly as possible starting March 3, 2026.
- Prizes for winning entries will be awarded as follows:

1st Place Adult \$502.50	1st Place Student 250.00
2 <sup>nd</sup> Place Adult \$250.00	2 <sup>nd</sup> Place Student 202.5
3 <sup>rd</sup> Place Adult \$102.50	3 <sup>rd</sup> Place Student 102.50

- In addition to the proposed awards above, the school from which the winning student submission comes will be awarded \$250 for the purchase of classroom supplies. The regional awards are in addition to whatever awards are given by the counties.
- The winning artwork submitted to the regional competition by the participating counties will be highlighted in the NC First in Freedom Festival Visitors guide.
- Pender County, NC First in Freedom Festival Committee, Pender Arts Council, Moores Creek National Battlefield, and Moores Creek Battleground Association maintain the rights to use photos of the art for marketing and promotion. The organizing committee reserves the right to not display any entry.



#### Mid-Carolina Rural Planning Organization (RPO)

#### Overview:

The Mid-Carolina RPO is a regional transportation planning organization dedicated to coordinating transportation planning efforts for rural areas in North Carolina. It serves regions not covered by Metropolitan Planning Organizations (MPOs) and was established to address the need for enhanced planning in these areas.

#### Core Duties of Mid-Carolina RPO:

#### 1. Comprehensive Transportation Plans:

Collaborate with the North Carolina Department of Transportation (NCDOT) to develop transportation plans for the region.

#### 2. Public Participation:

Facilitate community involvement to ensure diverse input into the transportation planning process.

#### 3. Project Prioritization:

Recommend and prioritize transportation projects for inclusion in the State's Transportation Improvement Program (TIP).

#### 4. Information Sharing:

Share transportation-related information with local governments, organizations, and the public.

#### Lead Planning Agency (LPA):

The LPA for the Mid-Carolina RPO is the Mid-Carolina Regional Council. The designated staff member is responsible for preparing documents, organizing meetings, administering state transportation funds, and supporting the directives of the Transportation Advisory Committee (TAC) and the Technical Coordinating Committee (TCC).

#### **Transportation Advisory Committee (TAC):**

The TAC is the governing policy body for the Mid-Carolina RPO. Its membership includes elected officials, local government representatives, and the region's representative on the North Carolina Board of Transportation. The TAC provides policy direction, coordinates communication, and helps guide the development of the regional transportation program.

#### **Technical Coordinating Committee (TCC):**

The TCC advises the TAC by providing technical recommendations. It includes staff from local governments, NCDOT, transit providers, and other relevant agencies. The TCC ensures that the planning process is well-coordinated and aligned with the region's transportation goals.

#### Mid-Carolina RPO Jurisdictions:

The Mid-Carolina RPO covers several counties and municipalities in the central region of North Carolina. These jurisdictions include:

#### Counties:

- o Bladen County
- o Harnett County
- o Cumberland County
- o Sampson County

#### Municipalities:

o Various towns and cities within these counties are also part of the RPO and collaborate on transportation planning efforts.

The RPO works closely with these local jurisdictions to identify transportation needs, prioritize projects, and develop plans that improve mobility, safety, and infrastructure across the region.

#### **Role of TAC Members:**

- Guide the development of transportation plans and priorities for the Mid-Carolina region.
- Foster collaboration and coordination among local governments, NCDOT, and transportation agencies.
- Provide policy direction to improve transportation infrastructure and services in rural areas.


