## 4. Request to Participate in the 2023 OSFM Grant Cycle

A. Fire Chief Dale Brennan is asking the Board to authorize participation in the 2023 OSFM Grant Cycle in hopes of securing grant funds in the amount of \$51,127.66 (\$25,563.83 OSFM Grant - \$25,563.83 local funds) (50/50 match) to purchase 4 - Air-paks, 8 - Cylinders, and 2 - Medium and 2 - Large face mask/face pieces to connect to the air-paks. #### 5. 2022 Tax Lien Advertisement

A. The Finance Office submitted FY Budget Ordinance Amendment #2023-06 (AGENDA ITEM #6.A) (\$15,256.00) to amend the General Fund's for the fiscal year ending June 30, 2023. This amendment is necessary to budget revenues and expenditures to remove and replace two HVAC systems. One in the CMRA (post office) and the large

one that services the administrative offices. Both units were 20+ years old and cost to repair exceeded allowance.
